*You had better come across or else take the consequences. Remember, this is wartime and anything can happen to you." After we had served some drinks to the officers, SHINOHARA took me by the hand and, with the Aide to the Governor, he led me into the bedroom and said: "This is your bed," meaning that I was to lie down there with the Aids to the Governor. After this SHINOHARA left and I and the Aide to the Governor slept in that room that night. We had sexual intercourse. I am willing to swear to Almighty God that, before that night, I was a virgin. I was 17 years old at that time. After that I asked serveral times of Mr. SHINOHARA that I be permitted to leave this life. To this he always replied: "You cannot go now that you are here and if you actually did go, you would be endangering not only your own life but that of your family. When we arrived in this house Grace Flores and a girl named Darling were living in the house and when we arrived they departed. SHINOH HA did not appear compelled in any way to procure girls for the Japanese. He appeared to be doing merely as a favor. He often said to us that we should be glad to be doing this for the high officials. My parents sent some food to us but SHINOHARA sent most of the food and drinks to the house. When we first went to work SHINOHARA promised that we would be paid 25 yen a month but he only paid us 20 yen a month and he often neg-lected to pay us at all. The Aide to the Governor accompanied SHINOHARA when he came up to the ranch, but the Aide did not do any of the talking. However, his presence frightened me. The Aide was wearing his sword at this time. Every day, while we were living in the Kerner house, SHINOHARA came to the house. He would check on whether we were there or not and then leave. SHINOHAR was so friendly with the officers that it looked like they were brothers. Before that first night at the Kerner house I had never drunk. However, I was for ced to drink whiskey by SHINOHARA and, as a result, I took about a half a jigger."

Has testified that: "About the 14th of February, 1942. SHINOHARA came to where I was living in Inarajan and asked me to come to Agana to live with the Jap officers there. I told him I did not want to go, but he mid that the Jap was not satisfied with the girl he had at that time and that he, SHINOHARA, had heard that I was better. He told me that if I did not come I would be put in a whorehouse for all the officers and that it would be better for me to come and live with this officer. His name was Hiyashi, the Governor of the island. I did not leave with them right away but waited until the following day when they returned and picked me up. SHINOHARA came the next day and picked me up. On the way to Agana we picked up Rosalia Torres who was living with Lieutenant Awata. I spent the night that night at Rosalia Torres' house. This house had been rented for Rosalia by Lieut. Awata. The following day Awata and SHINOHARA came and took me to Mrs. Kerner's house. SHINOHARA instructed me to clean up the house and make ready for the Governor's arrival. He also said that the Governor was a heavy drinker and I must serve him many drinks but I should not drink myself. This probably was because he knew that I drank and he did not want me to drink up too much of his stock. SHINOHARA told me that when the Gov rnor arrived I was to greet him at the door, take his coat and came, and have him sit down. When the Governor came that night I did that. The Governor was accompanied by SHINOHARA. SHINOHARA introduced me to the Governor and after a little while he left. He told me before he left that I must take care of the Governor. I understand that SHIMOHARA knew that I had a sister and shortly after I came to Mrs. Kerner's house, the Aide to the Governor asked me if she would come to the house to be a housegirl like myself. I said, no, that she was not like me and that she had a lot of work to do on the ranch. Naturally,
